A survey crew under my supervision, stakeout and located improvements around the perimeter of the Subject Lot A.

The following is a list of improvements located along with their respective positions.

- A. Tile Wall from Lot B extends approximately 0.5 of a foot into the Subject Lot A.
- B. Chain-link Fence from Lot B extends approximately 0.0 to 0.5 of a foot for a length of 26 feet into the Subject Lot A.
- C. Rock Wall from the Subject Lot A extends approximately 0.0 to 2.2 feet for a length of 50 feet into Lot B.
- D. Concrete Pavement from the Subject Lot A extends approximately 0.7 of a foot for a width of 4 feet into Lot B.
- E. Tile Wall is outside the Subject Lot A, said Tile Wall is inside Lot B.
- F. Asphalt Driveway runs across Gertz Lane, Lot B and the Subject Lot A.
- G. Rock Wall with Chain-link Fence from the Subject Lot A extends approximately 1.0 to 0.4 of a foot for a length of 25 feet into Gertz Lane.
- H. Rock Wall is outside the Subject Lot A, said Rock Wall is inside Gertz Lane.
- J. Concrete Steps are inside the Subject Lot A.
- K. Concrete Pavement runs across the Subject Lot A and Gertz Lane.
- L. Rock Wall with Chain-link Fence is inside Gertz Lane.
- M. Storage is inside Gertz Lane.

- N. Rock Wall straddles between Gertz Lane and the Subject Lot A.
- P. Rock Wall with Chain-link Fence from the Subject Lot A extends approximately 0.7 to 0.0 of a foot for a length of 13 feet into Lot 12-A.
- Q. Concrete Steps from the Subject Lot A extends approximately 6.0 feet for a width of 3 feet into Gertz Lane.
- R. Rock Wall is inside Gertz Lane.
- S. Metal Post is inside the Subject Lot A.
- T. Eave Line from the Subject Lot A extends approximately 7.0 feet for a length of 31 feet into Gertz Lane.
- U. Rock Wall with Chain-link Fence from the Subject Lot A extends approximately 3.0 to 0.0 of a foot for a length of 18 feet into Parcel 19.
- V. (3) Metal Posts from the Subject Lot A extends approximately 5.0 feet into Gertz Lane.
- W. Rock Wall with Chain-link Fence is inside the Subject Lot A.
- X. Rock Wall is outside the Subject Lot A, said Rock Wall is inside Parcel 19.
